Give Through Your IRA

Your Generosity Helps Restore Lives

If you are age 70½ or older, you may be able to support Wichita Falls Faith Mission by making a gift directly from your Individual Retirement Account (IRA) through a Qualified Charitable Distribution (QCD). This type of gift allows you to give in a tax-efficient way by transferring funds directly from your IRA to a qualified nonprofit.

If you are age 73 or older, your QCD may also count toward satisfying your Required Minimum Distribution (RMD) for the year.

What Is a Qualified Charitable Distribution?

A Qualified Charitable Distribution is a direct transfer of funds from your IRA to an eligible nonprofit organization. When the distribution is sent directly to a qualified charity, the amount is generally excluded from your taxable income under current IRS rules.

Because the funds move directly from the IRA custodian to the charity, the gift is not treated as taxable income for the donor.

Why Many Donors Choose QCD Giving

- **Tax Efficiency** - QCD gifts are typically excluded from your taxable income, which may help reduce your overall tax liability—even if you do not itemize deductions.
- **Helps Meet Your RMD Requirement** - Once you reach age 73, the IRS requires annual withdrawals from most retirement accounts. A QCD can be applied toward fulfilling that required distribution.
- **More of Your Gift Supports the Mission** - Because the funds are transferred directly from your IRA to the charity, the full amount benefits the ministry without first being subject to income tax.
- **Flexible Giving Options** - Your gift may be directed to support the areas of greatest need, including Faith Mission, Faith Refuge, the Capital Campaign, or other programs that help individuals experiencing homelessness and addiction.

How to Make a Qualified Charitable Distribution

Through a Qualified Charitable Distribution, you may be able to meet IRS distribution requirements, potentially lower taxable income, and invest in a life-changing ministry—all with one gift.
